

ORDINANCE NO. 2019-1

*An ordinance for the Levy of Taxes for All Town Purposes
for Chemung Township Town Fund for 2019 Tax Year Collectable in 2020*

BE IT ORDAINED by the Supervisor and Township Board of CHEMUNG TOWNSHIP, McHenry County, Illinois, as follows:

SECTION 1: That the sum of \$204,166.00 is hereby levied upon all property subject to taxation within Chemung Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township Town Fund as required by statute or voted by the people in accordance with the law, for such purposes as the Administration and Maintenance Fund for the year 2020.

General Assistance Fund:	\$ 4,513.00

SECTION 2: That the amount levied for each object and purpose shall be followed:

ORDINANCE NO. 2019-2020-1

*An ordinance for the Levy of Taxes for All Road Purposes
For Chemung Township Road District for 2019 Tax Year Collectable in 2020*

BE IT ORDAINED by the Supervisor and Township Board of CHEMUNG TOWNSHIP, McHenry County, Illinois, as follows:

SECTION 1: That the sum of \$430,066.00 is hereby levied upon all property subject to taxation within Chemung Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township Road District as required by statute or voted by the people in accordance with the law, for such purposes as the Administration and Maintenance Fund for the year 2019.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
