ORDINANCE NO. 2020-1

*An ordinance for the Levy of Taxes for All Town Purposes
for Chemung Township Town Fund for 2020 Tax Year Collectable in 2021*

BE IT ORDAINED by the Supervisor and Township Board of CHEMUNG TOWNSHIP, McHenry County, Illinois, as follows:

SECTION 1: That the sum of \$208,098.00 is hereby levied upon all property subject to taxation within Chemung Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township Town Fund as required by statute or voted by the people in accordance with the law, for such purposes as the Administration and Maintenance Fund for the year 2021.

Town Fund:	\$ 203,498.00
General Assistance Fund:	\$ 4,600.00

SECTION 2: That the amount levied for each object and purpose shall be followed:

GENERAL TOWN FUND:

Administration	\$ 201,809.00
Cemetery Expenses	<u>\$1,689.00</u>
TOTAL	\$ 203,498.00

TOTAL GENERAL TOWN FUND	\$ 203,498.00
TOTAL GENERAL ASSISTANCE FUND	<u>\$ 4,600.00</u>
TOTAL TAXES LEVIED	\$ 208,098.00

SECTION 3: That the Township Clerk shall make and file with the McHenry County Clerk on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
